



We are now a 501c3 Association

For the past several months our officers and Board of Directors have put into motion plans to secure 501c3 status for the Warren County Genealogical & Historical Association.

That plan has come to fruition as of June of this year.

On May 9 our Board of Directors met with Angela McCormack to hear her presentation on "Why You Need to Be A 501c3 Association". Her presentation was quite convincing and we contracted with her shortly thereafter to help us apply and receive this status. Angela is an Enrolled Agent with Pure Logic Tax Service and she is quite knowledgeable in the field of IRS tax codes.

What is a 501c3?

The term is used to define a charitable organization, named after Internal Revenue Code Section 501(c)(3), which gives such organizations tax-exempt status.

A majority of 501c3s are nonprofits. An organization with 501c3 status does not pay income taxes related to its nonprofit mission and purposes, is able to receive tax-deductible contributions, and is eligible for foundation grants. By law 501c3 organizations are required to not participate in any political or lobbying activity,

Wikipedia defines a 501c3 organization as:

A 501(c) organization, or simply a 501(c), is a tax-exempt nonprofit organization in the United States. Section 501(c) of the United States Internal Revenue Code provides that 29 types of nonprofit organizations are exempt from some federal income taxes. Sections 503 through 505 set out the requirements for attaining such exemptions. Many states refer to Section 501(c) for definitions of organizations exempt from state taxation as well. 501(c) organizations can receive unlimited contributions from individuals, corporations, and unions.

Exemption Requirements

To be tax-exempt under section 501(c)(3) of the Internal Revenue Code, an organization must be organized and operated exclusively for exempt purposes set forth in section 501(c)(3), and none of its earnings may inure to any private shareholder or individual. In addition, it may not be an action organization, i.e., it may not attempt to influence legislation as a substantial part of its activities and it may not participate in any campaign activity for or against political candidates.

The organization must not be organized or operated for the benefit of private interests, and no part of a section 501(c)(3) organization's net earnings may inure to the benefit of any private shareholder or individual. If the organization engages in an excess benefit transaction with a person having substantial influence over the organization, an excise tax may be imposed on the person and any organization managers agreeing to the transaction.

This brings a total of 90 certificates awarded.

There's still time for you to make your connection

To qualify for a Warren County First Pioneer Family Certificate suitable for framing, the applicant must directly descend from an ancestor (male or female) who was in Warren County no later than the 1820 census (this includes the boundaries of the original formation of Warren County from White County).

Proof can be established by submitting copies of an official record, I.e. birth, marriage, death, probate or will, church, cemetery, funeral or obituary, land records, tax records, court records, military records, census, newspaper, or family Bible records written before 1970, for each generation, including the applicant.

If your application is based on a previously approved application (such as a parent, sibling, grandparent, aunt, etc.) it is not necessary to resubmit documentation for overlapping generations. You need only send proof of descent for generations needed to link you to the previously approved applicant.

There is a \$10 application fee if certificate is to be picked up at the WCGHA office. An additional \$3.50 will be added if certificate is to be mailed. All applications and verifying material become the property of the Warren County Genealogical & Historical Association.

Current Tennessee residency is not necessary.




