Mortgages: In the 1800s and before, it was traditional when the daughter married, as part of her dowry, for the father to either cover their mortgage or carry a note for his son-in-law. If you can find to whom their mortgage payments were made, 70% of the time it will be the bride's father.

Campbell I certify, on honor, that I have carefully examined the above named volunteer, agreeably to the General Regulations of the Army, and that in my opinion he is free from all bodily defects and mental infirmity, which would, in any way, disqualify him from performing the duties of a soldier. I certify, on honor, that I have minutely inspected the volunteer Hardy A. Campbell previously to his enlistment and that he was entirely sober when enlisted; that, to the best of my judgment and belief, he is of lawful age; and that, in accepting him as duly qualified to perform the duties of an able-bodied soldier, I have strictly observed the regulations which govern the recruiting service. This soldier has BLUE eyes, LIGHT hair, FAIR complexion, is 5 feet 8 1/2 inches high. Stephen Tipton, Recruiting Officer.

Campbell who was enrolled on the 7 day of November 1863 in Co. E First Regiment of Independent Videt Cavalry in the war of the rebellion and served at least ninety days and was honorably discharged at Stevenson, Alabama on the 16 day of June 1864. That he is holey unable to earn a support by reason of dropsy and lung trouble [dropsy is a common sympton of heart, liver & kidney trouble]. That said disabilities are not due to his vicious habits and are to the best of his knowledge and belief permanent. That he has never applied for pension under application No. That he is a pensioner under certificate no. That he makes this declaration for the purpose of being placed on the pension roll of the United States under the provisions of the Act of June 27, 1890. He hereby appoints H. D. Phillips of Washington, D.C. his true and lawful attorney to prosecute his claim, and he directs that the sum of ten dollars be paid him for his services. A DECLARATION FOR ORIGINAL INVALID PENSION

State of Tennessee Grundy County, : on this 9 day of April A.D. one thousand eight hundred and ninety-one personally appeared before me a Justice of the Peace of the County, Grundy Hardy A. Campbell aged 67 a resident of the town of Altamont County of Grundy State of Tennessee who being duly sworn according to law, declares that he is the identical Hardy A. Campbell who was enrolled on the 7 day of November 1863 in Company E of the 1 Regiment of Tennessee & Alabama as a Sergeant commanded by Capt. H. Shannon and was honorably discharged at Stevenson, Alabama on the 16 June 1864. Height 5' 6" dark complexion, color of hair black that while a member of the organization aforesaid, in the service and in the line of his duty at Stevenson, Alabama or or about the 1 day of 186 he contracted disease of eyes and head there result from fevor and and has suffered from the same and effects thereof more or less ever since. That since leaving the service this applicant has resided in County, of Grundy in the State of Tennessee and his occupation has been that of a farmer. That prior to his entry into the service above named he was a man of good, sound, physical health, being when enrolled a farmer that he is greatly disabled from obtaining his subsistence by manual labor by reason of injuries above described. received in the service of the US and he therefore makes this application, for the purpose of being placed on the invalid pension roll of the US. He appoints Henry D. Phillips his true and lawful attorney to prosecute his claim. That he has not received but has applied for a pension. Mark of Hardy A. Campbell witnesses: William Winton and Albert Campbell. Personally appeared William Winton residing at Altamont and Albert Campbell residing in Grundy County, before J. M. Givens Justice of the Peace this 19 April 1891.

Frank Sweeton, age 22, of Tracy City, Tennessee and Thomas Campbell, aged 24, [Elit A. Campbell] of Altamont witnessed Hardy A. Campbell's application 22 June 1891. 29 June 1891 Hardy A. Campbell came before me, Justice of the Peace of Grundy County,

State of Tennessee . Said soldier "that he has not been in the military or naval service since June 1864 and further states that the company from which he was discharged was Co. E. First Regiment of Alabama & Tenn Vidette Cavalary. He further states that he was not in any hospital while in the service and the company had no physician but that while the company was at Nashville, Tennessee that he had a doctor there to wait on him but does not recolect his name nor does not know what command he belonged to.

Bird Campbell coffin at age 86 and burial at Harris Fults place cost \$15.00. On 28 May 1900 this entry was made at W. E. Garner, undertaker, for the town of Viola and in the possession of Mary Garner Jarrell of Morrison, Tennessee .

DECLARATION FOR WIDOW'S PENSION ACT OF JUNE 27, 1890

On this 20th of August 1900 personally appeared before me J.M. Givens Deputy County, Court Clerk within and for said County & state ELIZABETH CAMPBELL aged 73 years a resident of the 3rd District of Grundy State of Tennessee declares she is the widow of H. A. Campbell who enlisted under the name of Hardy A. Campbell on the third day of November 1863 in Serft. E. 1st Tennessee & Alabama Vid. Cav. and served at least 90 days in the late War of the Rebellion who was honorably discharged at Stevenson, Alabama 16 June 1864 and died MAY the 27th 1900. That she married under the name of ELIZABETH MYERS to said deceased 1844 by John Fletcher JP in Warren County, Tennessee . The mark of Elizabeth Campbell witnessed by signatures of Daniel Fults and George Fults. Pension office 21 April 1903: Elizabeth Campbell widow of Hardy A. came before me deputy County court clerk of Grundy declaring: that she was married to Hardy A. Campbell on or about the 15th day of November 1844 by John Fletcher a JP for Warren County, Tennessee . And that said JP is dead. And CRISS & JAKE MYERS was the only one present & that they are both dead. And, further state that the records of Warren County, were destroyed in time of the rebellion and that there is no record of our marrage. That I am unable to furnish the evidence asked for of our marrage but can prove by my neighbors that we lived together as man & spouse from the date of our marage to the date of his death MAY 7 1900 and that neither myself nor H. A. Campbell had been previously married and that I do not own any property neither personal nor real estate but live on a little mountainside place that belongs to the children and that there is no one legally bound for my support.

I, W. Wallis, Clerk of the County, Court of said County, do hereby certify that the records of marrages in this County are destroyed ormisplaced and am informed & believe they were destroyed ormisplaced in time of the War of the Rebellion. Given under my hand at office in McMinnville, Tennessee on this December 30, 1903.

Elizabeth Campbell widow of Hardy A. with witnesses Daniel Fults and John Tipton appeared before me a JP of Grundy County, : Daniel Fults states that I live close to the claimant and have lived as neighbors to her and her husband H. A. Campbell, decd., all the time since their married in 1845 up to the time of H. A. Campbells death and that they lived together as man and spouse up to his death and that they had not been previously married to any other persons and that the claimant has not remarried since her husbands death and that the claimant has not income of any kind. And, John Tipton for himself says that I was well acquainted with H. A. Campbell in his lifetime and is acquainted with Elizabeth Campbell and that they lived together as man and spouse from the time of their marrage up to the time of H. A. Campbells death and that they had not been previously married and that the claimant has not remarried since her husband death and that the claimant has no income and that I have been acquainted with them for about 60 years. On 20 January 1905 H. C. Givens and A. W. Campbell for Elizabeth Campbell aged 79. J. M. Givens, Notary Public, stated that he is well acquainted with the affiant and she is a credible lady. On 8 February 1905 pension office: That she is the widow of H. A. Campbell and that she knows he did not serve in the Navy or did no service in the army of the US nor in the confederate army before the 7 October 1863 and there is no one that I know of by whom I can prove the fact by. Pensioner dropped.

Knoxville, Tennessee 27 April 1906: Elizabeth Campbell who was last paid at \$8 to 4 Aug. 1905 has been dropped because of death. Died 30 August 1905. Hardy A. was paid \$12 to 4 May 1900 died May 29 1900.

Deamie Fults said Hardy Albert was a good dancer. Poor, hardworking man who loved the mountains. In 1880 they lived in CD 3 family # 125 of Grundy County, next to Calvin Myers and Daniel Fults.
