Thomas J. Harrison was born in 1853 to Jeremiah and Margaret Jane Harrison in Grundy County, Tennessee. He married Elizabeth J. Doran on January 9,1871 in Grundy County, Tennessee. Jeremiah Harrison was born in Alabama in 1824 to William Harrison . William Harrison was born in Lincoln County, North Carolina around 1786 and died in Grundy County, Tennessee in 1851. William was one of several children born to Thomas Harrison and Nancy Pack Harrison. Thomas Harrison was born around 1760 in Maryland and died November 2, 1839 in Coffee County, Tennessee which is now known as Grundy County, Tennessee.

Thomas Harrison came to North Carolina with Isaac Robertson along with his brother Richard Harrison. He married Nancy Pack in Lincoln County, North Carolina in 1764. Thomas and Nancy Harrison moved from North Carolina to Kentucky.



On the 7<sup>th</sup> day of March 1833 personally appeared in open Court, before the worshipful the Court of Pleas and Quarter Sessions for the County and State aforesaid of now sitting, Thomas Harrison, a resident of the County and State aforesaid and about seventy three years, who being first duly sworn according to Law doth on his oath make the following Declaration, in order to obtain the benefit of the Act of Congress June 7, 1832. That he entered the service of the United States under the following named officers served as herein stated. That he volunteered as a private soldier of a North Carolina Militia in the County c Lincoln in the year 1779 or 1780 as best as he recollects, to serve for a term of thre

months in the Company commanded by Capt. George Smith, Isaac Shockey

Lieutenant. We rondevozed at 12 Mile Creek in Mecklenburg County being at that

time the head quarters of General William Davidson. He was attached to a Regime Commanded by Colo. Dickson (or Dxon) number not recollected – from thence we marched into South Carolina crossing Peedee into Chersaw District, we were then countermarched to Salsberry in North Carolina, where we were stationed a short till guarding prisoners taken as well as he recollects at Rugely's Mill. He saw Rugely surrender his sword to Gen. Davidson this was

at 12 Mile Creek- Maj. Cook of the Tories was also a prisoner. He obtained a discharge but has it not in his possession. He sold it to Alex Steele in Lincoln Cour N. Carolina. Served the full term of 3 Months. During this time he was part of the time under General Green with the remainder of the army. He saw Genl Daniel Morgan while at 12 Mile Creek.

After being at home a short time, another call was made upon the Military of N. Carolina and having stood a draft in which he was not included, he hired as a substitute for Jacob Tipps for another term of 3 months in a Company Commander by Capt. Nail. We were marched to Fort Charles in Burke County where we was stationed nearly the whole time. The fort was called as he understands after Colo. Charles McDonnell who had the Command opf the Militia of Burke. During this time we were in the fort several skirmishes took place between the Whites & India On one occasion a Detachment was set to guard the family of one Armstrong living about two miles from the Fort. Here we were besieged by the Indians. We sallied forth & succeeded in returning to the Fort with no other loss but a Negro woman belonging to Colo. Warford. Part of the time he was engaged in guarding another family about twelve miles from the Fort. Having served the full term of 2 months, was again regularly discharged. He again substituted in the place of Conrad Rudol to serve another term of 3 months

Served under the same officers at Fort Charles the full term of 3 Months when he was again discharged. Not expecting his discharge was to at any subsequent time b of service to hi, he thinks the same was sold to Al. Steele, the third he does not recollect what became of it. He has no documentary evidence in his possession to prove his said service on any participation. Nor does he know of any person with it the reach, by whom he can prove any part of his said service, except his brother Richard Harrison of Alan County, Kentucky, whose affidavit taken before John Jones, John Sanders Esq. Justice of the peace of the County in hereunto affixed He

informed that said affidavit is not as complete as it might to be. But realizes? it is n as complete as it ought to be. But owing to his age and infirmities of the distance from hence to his brothers residence, it would be very inconvenient to require his attendance here or require his appearance:

He was born in Maryland about the year 1760 according to the family record of his age in the possession of his son in Alabama. When called into service he resided in Lincoln County N Carolina as before stated. He continued to reside there for sever; years. Sometime upwards of 30 years ago, he removed to Warren County Kentuck; From thence he removed to Franklin County, Tennessee, about 24 or 5 years ago. I removed

From Tennessee back to Kentucky, resided there a short time & removed to Indian then back to Kentucky –removed again to Missouri, & from thence to Alabama, where he resided about 2 years, then returned to this County, where he at present resides, & has done so for the last two years. He hopes he is not settled for live, aft rambling over almost all the Western States.

You are furnished herein the record of Thomas Harrison as found in the papers on file in pension claim W. 360, based upon his service in the Revolutionary War.

Thomas Harrison was born about 1760 in Maryland; the exact location of soldier's birth and name of his parents are not given.

While residing in Lincoln County, North Carolina, Thomas Harrison volunteered is 1779 or 1780 and served three months as private in Captain George Smith's company, Colonel Dixon's North Carolina regiment. After this tour he remained at home for a short time then enlisted, date no stated, served three months as private in Captain William Nail's company, Colonel Charles McDowell's north Carolina regiment, and was in several skirmishes. He served another tour of three months

under the same officers.

The soldier left the State of North Carolina in 1795, after which he lived in Warren County, Kentucky; Franklin County, Tennessee; to Indiana; from there back to Kentucky; from Kentucky to Missouri; from there to Alabama where he lived for two years, after which he returned to Franklin County, Tennessee.

Thomas Harrison was allowed pension on his application executed March 7, 1833, while residing in Franklin County, Tennessee.

The soldier died November 2, 1839.

Thomas Harrison married in 1783, or the fall of 1784, in Lincoln County, North Carolina, Nancy Pack.

Soldier's widow Nancy Harrison, was allowed pension on her application executed September 17, 1845, at which time she was aged eighty-one years and residing in Grundy (which was formerly Franklin) County, Tennessee. In 185?1 it was stated that she was ninety-one years of age, and in 1852, ninety years of age, and still livi in Grundy County, Tennessee, with her daughter Susannah Sartain; no explanation was made of the discrepancies in age. She died March 10, 1854.

In 1795, Thomas Harrison and his wife, Nancy, had five living children. The following names were given:

William, the oldest, born November 9, 1786, and dead in 1851.

Hohnson, in 1846 a resident of Madison County, Alabama

Susanah or Susaannah Sartain, the third child, born October 2, 1789, and in 1851 living in Grundy County, Tennessee, at which time she stated that the two children older than herself were dead.

¥Elijah, the fifth child, born July 27, 1794, and in 1852 living in Grundy County, Tennessee.

In 1833? Soldier's brother, Richard Harrison, of Allen County, Kentucky, made affidavit in Franklin County, Tennessee, and stated that he served with Thomas Harrison on one of his tours.

There is no claim for pension on file based upon service in the Revolutionary War a Meredith Thorne. No claim for pension could be identified as that of the Roberts in whom you are interested. Such claims are the source of Revolutionary War data furnished by this office. There are no general genealogical data on file as a means a tracing ancestry and no clerical force assigned to genealogical research. The record of one Thomas Harrison, only, of Tennessee, has been found. That record is given herein and may be that of the one in whom you are interested. The data are found it pension claim W.360, based upon his service in the Revolutionary War.

Some time ago I asked you for information about Captain John Scott of Prince Edward County, Virginia, and I have rejoiced ever since your reply came. I appreciate all the thoroughness of research and all the details you included, all of which meant much to me since I had exhausted all other sources and was able to make sure of the various clues in your research.

The success of this has lead me to feel that perhaps other lines that I had considered hopeless might be traced, and I shall be most grateful for your continued assistance with them. My grandfather Meredith Thorne Robertson, was named for some member of his grandmother's family. His grandmother was Patsy Thorne (Martha) and she married Willie (pronounced Wiley) Robertson and came from somewhere North Carolina to Robertson County, Tennessee, in 1807. We believe that perhaps our grandfather was named for Patsy's father and we have found some slight trace a Meredith Thorne in North Carolina. In the first census of North Carolina Meredit Thorne was named, but we can find no will or other record of him. I hope you have some record of him, or of some other Throne that will tell us something of the ancestry of Patsy.

Page 28

We are also concerned about the parentage of Willie Robertson. He and Patsy had five children when they came to Robertson County, Tennessee, in 1807, which

would indicate that they were born about the time of the revolution. It may have be possible that their fathers fought in the Revolution. We know nothing of Willie's relatives except that he was cousin of General James Robertson the "Father of Tennessee." Perhaps that is not enough information for you to work on, but I do he it will be.

There was a Thomas Harrison who came to Robertson County Tennessee, about 1800 who has baffled us. My great-grand father, William Harrison, came in 1812 and settled on the property owned by Thomas. William seemed to have come directly from Mecklenburg County, Virginia, but there is a tradition that the family lived in Harrisonburg, Virginia. He was closely related to William Henry Harrison the president. We cannot trace the relationship of Thomas, who came to Tennessee early in the history of the state, and our William who came later. We hope that Thomas may have a Revolutionary record that will straighten it out.

A paper writing purporting to be the num capative will of the late Andrew J. McGown was this day brought into open Court together with the records from the Circuit Court of Grundy County showing the establishment of said will at the May Term 1851 of the Said

Court upon an Issue devisavit vel non to be spread upon the records of this Court which being ordered-Florinda C. Harrison late Florinda C. McGown wife of said testator by herself and next friend and Husband Garrison Harrison thereupon comes here into open Court and Enters her dissent from said will as the widow of said Andrew J.
