#### INTRODUCTION

The Northcut Family Papers, composed of letters and documents belonging primarily to H. B. Northcut and his sons, Tom and Jim, were obtained by purchase from the Fanny Moffitt Estate in Altamont, Tennessee, December 2, 1955.

The materials in this collection measure 4.84 linear feet. There are no restrictions on the materials. Single photocopies of unpublished writings in the Northcut Family Papers may be made for purposes of scholarly research.

#### SCOPE AND CONTENT

The Northcut Family Papers, numbering approximately 1,750 items, consist largely of record books, notes, cancelled checks, and receipts accumulated from the Northcuts' mercantile business. There are also legal and business documents and many business letters. The documents, which are the most interesting papers in the collection, consist of business agreements, land deeds, Grundy County Court records of 1895, and records of the Northcut family civil suit of 1892. The record books are arranged in two series. The numbered series are the charge account records of the Beersheba Springs store, and the lettered series are the records of the Altamont store. There are also records of checks received and cashed and records of wholesale purchases. The record books date from 1866 to 1938. The bulk of the material in the collection falls within the period 1860 – 1895, but the inclusive dates range from 1854 to 1942.

The correspondence and notes in the collection belonging primarily to H. B. Northcut and his sons, Tom and Jim, deal with land transactions, coal mining, mercantile business, and law suits. The Northcuts, the most prosperous merchants in Grundy County, owned large quantities of land, leased out mining rights to local coal mining concerns, and loaned considerable sums of money which invariably involved them in civil court cases. There are a few personal letters in the collection, but among them are some very interesting letters for the Northcut's unfortunate debtors, who became delinquent in repayment.

The collection includes an interesting diary, probably of J. B. Ritchey relating his experiences with a Confederate wagon train as it moved through Tennessee, Georgia, and the Carolinas during the last two years of the war. Also included is a diary of Jim Northcut for 1939, an autograph book of Timmy Northcut, and various miscellaneous notebooks, literary efforts, etc.

## **BIOGRAPHICAL SKETCH**

The Northcut mercantile, land, and coal fortune was begun by Adrian Northcutt (1799-1869) who established a trading post at Altamont in about 1825, which developed into a large general store in the 1840s. Adrian's son, H. B. Northcut (1829-1910), began managing the store in 1850 and took over the business after his father's death. After the Civil War, H. B. Northcut established a second store in Beersheba. By 1890, his two sons, Tom (1864- ) and Jim (1867- ), were operating the two stores. They also operated a hotel in Beersheba Springs. H. B. Northcut's only daughter, Timmy (1870-1928) was educated at the McMinnville Female Academy and was a woman of intelligence. She married James Moffitt (-1896). Their only child, Fanny (1893-1955) eventually became heir to the Northcut fortune. The Northcut store in Altamont closed during the Depression. The store in Beersheba Springs was take n over by the Brown family after Tom Northcut's death and is still owned and run by the Browns.
